- Sun 7/10/11 Kick-off dinner somewhere in the Denver area. Ralph is in the process of locating a sponsor and location.
- Mon 7/11/11: Travel to the Black Hills of South Dakota. Probably spend the night in Deadwood, South Dakota.
- Tues 7/12/11: View Mt Rushmore and other area attractions in the morning. Leave area after lunch heading east. Drive approx 200 miles to Chamberlain, South Dakota for the night.
- Weds 7/13/11: Drive to Albert Lea, Minnesota for next night's stay, approx 300 miles (possible stops along the way).
- Thurs 7/14/11: Drive 265 miles to Oshkosh, Wisconsin. Possible lunch stop in La Crosse

(Mississippi River). Spend the night in Oshkosh.

- Fri 7/15/11: Drive to Elkhart Lake, WI to Road America race course (www.roadamerica.com) to watch vintage car races. Ralph is working on several special “perks” during the day at the track. For those not interested in this venue, there is a maritime museum in Manitowoc (www.wisconsinmaritime.org) that, among other things, has a WW II submarine on display. You may decide to split your day between these two venues. Return to Oshkosh to spend the night (same hotel as the night of 7/14).
- Sat 7/16/11: Visit Experimental Aircraft Association Museum in the morning (www.airventuremuseum.org). Leave Oshkosh sometime before noon to arrive at dock in Manitowoc in time to board auto ferry (www.ssbadger.com) (www.howderfamily.com) for trip across Lake Michigan to Ludington, Michigan. Crossing time is approx 4 hours. Spend the night in Ludington.
- Sun 7/17: Drive to Hickory Corners, Michigan (approx 160 miles) to visit Gilmore Auto Museum (gilmorecarmuseum.org) with rest of NCRS road tour legs. - Mon 7/18: Drive to Novi, Michigan for road tour caravan into convention site in Novi.

January School

In January I'll finish the 2-part judging school I kicked off last September. The focus was on the new 8th Edition of the NCRS Corvette Judging Reference Manual. We covered the first half of the book.

The second half focus' is on the various award recognition programs NCRS offers. A few are new and merit discussion. Also, if you're a new member, seeing the other awards (beyond Flight Judging) might help focus your objective for your car.

2011 National Road Tour

Ralph Ridge took a few minutes at our last chapter meeting to brief us on his plans for the Rocky Mountain Chapter's leg of the 2010 National Road Tour. The

National Convention this year is in Novi, Michigan—a western suburb of Detroit.

And, those who are still in business probably don't have records going back that far...

But, fellow members persist in their hunt by posting questions to those on the DB who might have additional information. Most come up dry, but a few break through results have been reported. A few clever angles mentioned include:

- (1) Consider hiring a private investigator to help the search
- (2) If the car came from a smaller town, consider placing a local newspaper ad

1963-74 Reproduction Heavy-duty Rear Leaf Spring

If you are contemplating a purchase of an optional heavy duty rear leaf spring for your 1963-74 Corvette I offer this evaluation of one that I recently purchased.

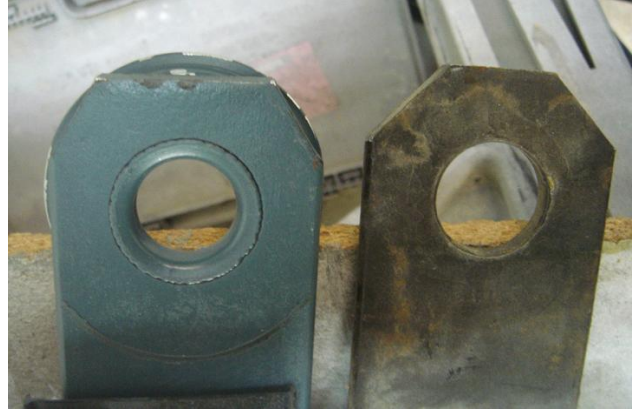
I saw an advertisement in the driveline from America's Finest Corvettes (AFC) where the ad stated that a heavy-duty 7 leaf rear spring is now available and is correct in performance (spring rate) and visual appearance as the original. I decided to give them a call and order one.

The visual inspection is the only extent I can relate at this time. [For verification of specifications referred to in this article, see Volume 30, Number 4 Spring 2004 Restorer article "An Examination of the 1963-1982 Heavy-Duty Rear Spring" by Gary Beaupre and Joe Lucia] Visually, this spring has very nice original appearing scallops and trimmed edges in leafs 2-7.



The spring dimensional thickness is .276. This dimension is somewhat thicker than the original specs for 63-74 but identical to spring thickness for leaves 3-6 in the 78-79 spring. The spring comes with retainer cups which is a bonus as these are difficult to install without the proper tools (more on that later). I have purchased springs from other manufacturers and the cups were not included. These cups are the current service replacement style, which means they are visually thicker or deeper, depending on how you describe it, but if that doesn't bother you, you are good to go. [You can review the aforementioned article in the Restorer to examine this aspect in detail]

The trimmed ends of the main leaf were not cut as in a typical production 45 degree angle. They are much shallower and need to be reworked. Chopping these ends seems to be the bane of the spring

industry. I had the same trim issue with the Eaton spring that I purchased in 2005 (Eaton Spring in Detroit was the original supplier and still makes a spring for this application). Apparently making this angle cut following the original engineering drawings of the 60s and 70s is not closely scrutinized.

To rework the ends of the main leaf to my idea of the correct angle, I had to remove the retainer cups (which were visually the wrong configuration anyway, as previously mentioned). Referring to the article from 2004, Gary listed a solution for the retainer cups. I emailed him and found out that he has created a set of tools that he loans out at a modest price to



install the modified retainer cups that he makes from the GM service replacements. I ordered the cups and the tool from Gary. The process was very easy and the results were very satisfactory. (pic.4)

You may notice the color of the spring in the first picture. The color picture is very accurate in terms of the actual color of the AFC spring. It is a medium shade of blue. It is advertised as the correct color. I understand that the 1963 spring only is black. In discussing this with Gary via email he indicated that his research revealed there was an Ikonoclas preservative

type coating originally specified in the engineering drawings and that it was more gray than blue and very thick like "oatmeal". Apparently Quanta Products used to sell this mixture but has not been able to obtain a suitable supply and no longer sells it. In reviewing the judging manuals a light gray primer is "expected" to be seen. The discussion board has many posts on the subject all around the 2005-6 period with many members weighing in on a light gray type solution being the overall end result. I stripped the spring and repainted it with a light gray urethane aircraft primer.

You be the judge (no pun intended).
