## RMC Judging Chairman Report

It's newsletter time again! Let's see what to say... Heck, that's easy there's always something happening at NCRS.

First, on the look ahead locally, we've got a Judging School on the docket for November. This will be a video with stop and group discussions on the topic of Operations judging. I hosted this school at our 2008 Regional meet and it was mostly attended by non-RMC master level judges who gave generally high marks on their ability to learn something new!

Plus, next year, we're 'go' for a repeat of last year's Chapter judging meet at Bozarth Chevrolet. Next year we're on for Sunday, March 21<sup>th</sup>. I'll be putting together the registration ad soon to get it in print for the newsletter as well as NCRS *Driveline*.

## New Judging Recognition Reporting System

I briefly covered the new system for reporting points earned and current status in the NCRS Judging and Tabulation Recognition Systems at our last Chapter Meeting. For those not present, here's the low down.

The 'new' system went into effect mid-September of this year. Instead of filling out paper forms with who did what and sending them by mail to the National Judging Chairman, NCRS has created a direct entry system using the club's website. Each judging chairman responsible for a point qualifying event (judging meet, judging school, judging seminar, Etc.) is responsible for going on-line, logging in and posting the details of who did what.

That pushes the raw data entry task down to the even source(s), and frees the National Judging Chairman from rote data entry 'drudge' work. He still retains final review and acceptance authority to approve the data that's entered and turn it 'loose' to the overall club data base. So, the applicable meet judging chairman does NOT have final authority over what's credited to a member's account. But, the days of paperwork lost in the mail, paperwork that's unreadable, and typographical errors is essentially over!

How do you see where you stand? Easy! Just go create an account for yourself at the NCRS National web site if you don't already have one.

Specifically, fire up your web browser and navigate to the NCRS National web site ([www.NCRS.org](http://www.NCRS.org)). Click on the Technical Discussion tab and that'll take you to the club's open forum for restoration and preservation chats.

Here, you'll find a tab for Account Initiation. Anyone can navigate to this site and 'see' what's being talked about, but only registered members can make posts and participate in the technical discussions. So, you need to be an NCRS member and register to actively use the site and you do this via the Account Initiation process.

Once you're duly registered, you simply log in and click on your Profile to see your current standing in the NCRS Judging and Tabulations Recognition Programs. You'll see your historic point total(s) as well as the source(s) of points added recently to your account. SIMPLE!

## Regional Meets

The Texas Regional was held in Killeen, Texas on October 15-17<sup>th</sup>. RMC was well represented with at least nine members being present. I use the term 'at least' because I did not attend and I'm going by reports from those who were there.

Messrs Banks, Cadenhead, Egan, Gregory, Hilborn, Kazmierzak, Marsico, Mulick, and Pyzel are among the notables in my reported headcount. Martin Egan received honors and garnered his Black Hat. Peter Gregory entered his car for Flight Judging and received a Flight Award. So, for a regional meet over one thousand miles from Denver, we 'done good' in terms of participation!

The annual NCRS Regional meet in Florida is always popular and it's scheduled for 1/20-1/23 next year (2010 if you've been distracted lately). The Australia Chapter holds it 'See Australia' event in Perth with a cross-country train tour from Sydney to Perth 3/27-4/7/2010.

## Tech Session Report

Following the Membership meeting on October 17<sup>th</sup> Jim Lennartz and Gary Setffens led a discussion on how to “winterize” your Corvette and other cars that may not be used during the hard of winter that is now upon us here in the Front Range. The following are a list of some of the items discussed and can be used as a guide in preparing your car for hibernation.

**Gas** – with the addition of ethanol and other additives to our fuel mix the shelf life of gas is about three months. Ethanol is hydroscopic and as such absorbs water (i.e. from moisture in the air). The water collects in you tank (at the bottom because it is heavier than gas) and can cause corrosion and starting problems when spring rolls around. Fuel stabilizers (like STA-BIL) can help mitigate the effects of moisture absorption. The fuel stabilizer sets a protective layer on the top of gas to help lower the moisture absorption rate. If you don’t empty your lawn mower gas tank its good for this as well to help get your mower going on the first couple of pulls in the spring.

**Oil** – it was suggested to change your oil as during engine operation there is a build-up of impurities and acids that could result in deposits or chemical attack inside your engine.

**Tires** – fill your tires with air or nitrogen to the maximum pressure, especially nylon tires, to help keep them from getting flat spots from sitting dormant with the weight of the car on them.

**Suspension** – if you are going to lift your car and put it on jack stands (to avoid the tire flat spot issue) it’s a good idea to support the suspension components so they are not stressed from the weight of the free hanging wheels/tires. It was suggested to lift the car but leave the tires in contact with the ground. That way you are taking a lot of the weight off the tires and not stressing the suspension system. It will also give your Corvette that cool “monster truck” look. Be sure to explain to anyone stopping by your garage what’s going on so as not to make them think you put a lift kit on your ride.

**Wiper Washer** – if your car will be exposed to sub-freezing temperatures, it’s a good idea to empty the wiper wash container to prevent freezing/breaking of system components.

**Battery** – most “battery tenders” cycle too many times and tend to over-cycle the battery. It was suggest to rotate the battery tender on and off, for example plug it in for a day or so and then unplug it for a week or two. You could also use a timer to cycle it on and off. During this part of the session a little trick for a “dead” battery was brought up. Because a chemical reaction within the battery causes current flow, it was suggested that prior to starting a car that has been sitting for awhile, or has a weak battery, to turn on the lights for a few seconds prior to hitting the starter, to get the chemical reaction going, which can give the battery the boost needed to provide the amps the starter pulls. Something to try next time you have battery problems. However, if you left your lights on overnight, I’m thinking you don’t want to rely on this to get you going the next day.

**Radiator/Cooling System** – it’s a good idea to flush and renew the coolant system prior to long-term storage. Remember it is best to use distilled water when filling your system as it doesn’t have the additives tap water has which can result in corrosion problems.



**Little Visitors** – I’m not talking about kids/grandkids, this is the four-legged type in the form of mice. If your storage area (and therefore car) could be a nice nesting place for mice then you definitely want to keep an eye out for them as they can cause SERIOUS damage, especially to your electrical system. Apparently the dryer sheets used to freshen up your shop clothes works well to deter mice from getting into your car or garage. It was suggested to put a dryer sheet on the floor by each tire of your stored car and put them at your garage door entrance (and any other entrance). This will also make your garage smell all fresh and clean.

**Engine Start** – once a month you should start the car and get it up to operating temperature and if possible drive it a few miles to move the suspension components and get the fluids moving in their respective systems. If the car has been setting longer than a couple of months you may want to first

disconnect the coil wire and turn it over to build up oil pressure to lubricate the valve train prior to firing up.

Insurance – if you store your car during the winter and don't drive it and change your insurance coverage as a result, you should verify with your agent that you have coverage in case of theft, fire, or some other event that could result in loss or damage. Also, if you put your insurance on hold during the winter and there is a nice day during that time when you want to start the engine, as discussed above, and go for a quick spin, tell your insurance company and often you may be able to do this for a minimal, if any at all, cost.

These are most of the suggestions that came from the tech session and I'm sure there are some additional items you have thought of. If so, please feel free to let me or Dennis Dalton, our newsletter editor, know and we'll list them as an addendum in the next newsletter.
