The Rocky Mountain Chapter will hold a Chapter Judging Meet and one point judging school on May 3, 2015 at Bozarth Chevrolet on So. Havana Street in Aurora, CO. We will be judging a maximum of eight cars, evenly divided between; 53-62, 63-67, 68-82, and

84-96. No judging team will be asked to judge more than two cars.

The doors will open at 6:30 A.M., and all judged cars must be on the judging field before 7:30 A.M. A one point judging school on taking originality deductions during flight judging using CDCIF (configuration, date, completeness, installation, and finish) will start promptly at 8:00 A.M. Dennis Dalton will be leading this judging school. There will be a brief judges meeting at 9:00 A.M. followed by an owners meeting. Flight Judging will begin at 9:15 A.M.

On-line registration will open on Feb. 2, 2015, and cars will be accepted for judging based on the timeliness of their registration. Everyone attending must register, and in order to be considered for a judging assignment your on-line registration must be received by April 6, 2015. Lunch will be provided for all registrants except those who register at the door. The late registration fee is \$15. No cars will be accepted for judging after the April 6 registration date. The Flight Judging entry fee is \$50.Sportsman entry is \$15, and all driven Corvettes may be displayed on a space available basis.

On-line registration can be found on the NCRS technical discussion board; click on Event Registration, or you will find a link on the Rocky Mountain Chapter web site when registration opens. This event presents a great opportunity to pick up three valuable judging points, or give your car a final judging before the National Convention in Aurora in July.

1966 Corvette, 2 top 427 Roadster number 7718. Original owner with original invoice. 390HP/4 speed. Never hit body in original Milano Maroon with Black interior. Very well maintained car as original—true Survivor example with 133,000 miles. "IL" engine has never been touched other than routine maintenance. To my way of thinking, this car is screaming to be a Bow Tie Candidate or, is ready for restoration with all the hard parts still present. It was custom ordered and optioned, when new, with 4 speed, 390HP BB, White walls, AM/FM, Aux. Hardtop, 3:36 Posi, and Teak Steering Wheel. Paperwork includes Dealer Invoice, Owner's Manual, Radio Instructions, Owner Protection Plan with Plate, and original factory keys. Luggage Rack was dealer add-on. Tonawanda stamp reads "TII23IL". VIN shows nicely on block pad and tag under glove box. Intake dated J-30-5. Plate under the glove box reads Trim, Std., Body A-2507, Paint 988, Style 66 467.

Car has been sitting in heated storage for 20 years. With a new battery and fresh gas, it started right up. Sounds right with no extra noise, blow by suggests stuck rings? Right bank smokes out exhaust. This was not the case when the car was parked? Brakes are up. Tach cable was disconnected some time ago. Rest of gauges work and are clean. Antenna mast is missing, base is present. AM/FM radio is original. Not sure if it is still working? Clock does not work. Original seat belts. Parking Brake does not hold. Oil leak back of Intake Manifold. Headlight Motors work as new. New Master Cylinder with new brake lines.

Lacquer paint is worn consistent with age. No question as to being an un-hit, virgin sort of body!! All body gaps are as good as new. Nose has been scratched as well as LF fender skirt. Original wheel covers show wear and age. Stock steel wheels with spare in tub. Uni-Royal radials at about 70% tread. Windshield is not cracked, but does have scratches on driver's side. Door Window glass is good. They crank fine and are loose in tracks consistent with age. Frame has flash type rust, but no cancer or rust through. Rear Wheel kickups are solid in frame. Bumpers are nice for street use. No dings or rust through. Exhaust is hanging lower than it should be, but seems tight? Convertible top and frame are off car, but complete. Rag top has bad stitching. Hardtop is good, some crazing in rear glass where middle bolt goes through. All stainless is mint. One split in Driver's Seat. Passenger seat is good. Both Door Panels look nice each having a small crack. Driver's Arm Rest has ding. Original carpets are good for their age. Comes with original Jack and Lug Wrench. Glove Box Door is mint. New battery tray. Teak wheel is worn, but not cracked or chipped. \$65,000 FOB Steamboat Springs, Colorado.

This was recently published in the Long Island Newsletter which was taken from Machinist Workshop Magazine. I thought I would pass this along as a item of interest. ED

Machinist's Workshop Magazine recently published some information on various penetrating oils that was very interesting. Some of you might appreciate this. The magazine reports that they tested penetrates for break out torgue on rusted nuts. They are below, as forwarded by an ex student and professional machinist. They arranged a subjective test of all the popular penetrates with the control being the torque required to remove the nut from a "scientifically rusted" environment.

Penetrating oils Average torque load to loosen

No Oil used	516 pounds
WD-40	238 pounds
PB Blaster	214 pounds
Liquid Wrench	127 pounds
Kano Kroil	106 pounds
ATF*-Acetone mix	53 pounds

The ATF-Acetone mix is a "home brew" mix of 50 -50 automatic transmission fluid and acetone. Note this "home brew" released bolts better than any commercial product in this one particular test. Our local machinist group mixed up a batch and we all now use it with equally good results. Note also that "Liquid Wrench" is almost as good as"Kroil" for about 20% of the price. Steve from Godwin-Singer says that ATF-Acetone mix is best, but you can also use ATF and lacquer thinner in a 50-50 mix.

*ATF=Automatic Transmission Fluid
