
The February get together was at the Forney Museum. I was out of town and unable to attend, however I heard we had a good turnout.

Vice Chair Report By John Marsico

I thought it would be appropriate for my report to give the membership an update on our charity. As I'm sure most of you know, our charity for 2011 is the 9Health Fair. We not only donate financially to this cause, but we also provide volunteer power staffing the telephone lines during the Spring Fair. I am including a brief history of the event for those newer members who may not be familiar with the 9Health Fair's development.

9Health Fair Mission: To promote health awareness and to encourage individuals to assume responsibility for their health.

In the late 1970's, John F. Brensike, a physician conducting heart disease research at the National Institutes of Health in Washington, D.C., became involved in cholesterol screenings. As he traveled the country, he observed a high level of interest from communities to provide screening services. However, he noted that few screenings were available and the quality varied. But more importantly, he noted that there was no mechanism to provide health education and medical follow-up to the community. From there, Dr. Brensike started the National Health Screening Council for

Volunteer Organizations (NHSCVO) as a means of promoting preventative health maintenance. Through this organization, the health fair concept was born. The idea was presented by NHSCVO to interested communities across the country. In Colorado, NHSCVO approached Al Flanagan, then president of KBTV Channel 9 in Denver, now 9NEWS. The television station recognized this effort's value to the community and agreed to provide both financial and media support to help launch the first health fair.

In 1980, along with support from hundreds of medical and non-medical volunteers, the Lions Clubs of Colorado and the Colorado National Guard, the first 9Health Fair was staged. To this day, all three groups remain steadfast in their important roles with the 9Health Fair as important in-kind sponsors.

In 1987, 9Health Fair became a 501(c)(3) non-profit organization. With the sole mission of promoting health awareness and encouraging individuals to assume responsibility for their own health, and because of the support of 19,000 statewide volunteers, 9Health Fair has helped save thousands of lives by providing free and low-cost health awareness and educational screenings. To date, 9Health Fair is the only program of its magnitude and that has become a community institution as a result of the NHSCVO initiative. Since inception, 9Health Fair has impacted over 1.7 million individuals

The Spring Fair is just around the corner and I will once again be looking for volunteers to staff the hot line at the Channel 9 studio in April. If this peaks your interest, please email me to get

RMC Judging Chairman Report By Jack Humphrey

Happy New Year! We survived our holiday party, the ski resorts are open and the days are getting longer now. This report will be brief as there's not much judging action taking place.

#### January School

In January I finished the 2-part judging school I kicked off last September. The focus was on the new 8th Edition of the NCRS Corvette Judging Reference Manual. We covered the second half of the book; essentially a primer on the club's various award/recognition programs. Those who attended have been turned in for credit. Both the school and credits have been approved. You should now see your judging points updated with this event when you view your on-line profile.

One issue was left open and I'll close



that out now. Ralph Ridge asked a question about the Sportsman Award. Specifically, he asked whether those NCRS members with more than one Corvette in their stable could mix & match the use of their cars for earned points to achieve the award. My initial take, based on the specific text of the Sportsman Award's purpose/description and requirements sections was negative. The English language used consistently refers to the Corvette in the singular form. That suggests, a member may only participate in the Sportsman Award with a single car from his/her stable... It turns out that interpretation is NOT true! Had either of us read further, we would have discovered award framer's had already considered this aspect and ruled favorably on the member's ability to mix and match car usage. Specifically, provision E of the Requirements section reads:

"May accumulate points with the same Corvette or with different Corvettes"

The requirement that the Corvette(s) actually be owned by the member survive with the new rule exception allowing member(s) residing outside North America to earn Sportsman points when he/she visits North America and borrows a qualified Corvette. This exception is specific and, apparently, does NOT apply to NCRS members who are North American residents who travel outside the North American Continent to participate in NCRS judging events held there.

Next Judging Event
I've heard from a few members who
were confused about our judging event
plans for 2011. I'll clarify.
We have PERMANENTLY moved the
annual chapter judging meet from the

spring to the fall in consideration of weather relief. There is NO meet on the schedule for the March/April time frame. Further, at our January Board of Directors meeting I proposed, and the Board approved, a schedule change for this fall. Currently, the club calendar slates a judging school for September (Saturday, the 17<sup>th</sup>) and a judging meet for October (Sunday, the 16th). These events have been effectively 'swapped'. Why? When we initially set our 2011 calendar, we didn't note there were two Regional meet events surrounding the October date we picked for our Chapter meet. The week before, there's a Regional set for California and the week after holds the Texas Regional. RMC folks have a history of attending both of these meet locations. So, to preclude a potential conflict, we exchanged the September judging school with the October chapter judging meet. Since our sponsor, Bozarth Chevrolet, actively works their service center on Saturdays. the exchange isn't exactly 1:1 on the calendar.

Mark your copy of the calendar for the chapter judging meet on Sunday, September 18<sup>th</sup> at Bozarth Chevrolet and pencil the judging school in on Saturday, October 15<sup>th</sup> at Corvette City. The official calendar on the RMC web site has already been updated.

2011 National Convention Our volunteer labor to help NCRS National beta test the on-line registration system has paid off! The online registration software for this year's National Convention in Novi, Michigan when operational February 1st. I registered postage free, in approximately 5-minutes. I've also chatted with a few RMC members who reside outside North America and they expressed satisfaction with the on-line system. In the past, notice of the convention was all manual via the club's Driveline publication that's sent by US mail. This is a decided disadvantage to those club members who live literally an ocean away from us! For the first time, they were able to register for the National convention at the same time as us, remit payment electronically (with automatic currency conversion) and NOT be 'second tier citizens'... If you intend to go to the National and haven't registered yet, I encourage you to use the on-line system. It's the way of the future. Plus, once you've visited and navigated the on-line registration web site, the next meet you attend will be that much easier to register for! Steer your web browser to the NCRS National web site (www.ncrs. org) and click on any of the 2011 NCRS National Convention buttons that appear on the main page.
