RMC Judging Chairman Report by Jack Humphrey

#### New Judging Guide Books

Since our last newsletter aired, four new Technical Information Manual and Judging Guide books have gone to press. We knew about the long awaited 1968-69 JG since a 'trickle' of these 4<sup>th</sup> Edition books went out to those on back order and team members received their courtesy copies. But, shortly after those books shipped, a hold was applied. Contributors noted photographs weren't up to snuff in terms of clarity and there were a handful of other areas where edits were submitted but somehow missed being included. Anyway, I'm told those 'oops' issues have been fixed and the full update is once again available although I've not yet received the RMC copy.

Next, the on again/off again 1963-64 JG book has been re-released with the revision rolled up to the 6<sup>th</sup> Edition. Moving on to C3 and C4 lands, there's a new 4<sup>th</sup> Edition of the 1980-82 book and a 2<sup>nd</sup> Edition of the 1984-86 Judging Guide. So, if what I've sketched lands close to home, it's probably time to order newly updated books for your support library!

#### First 2013 Judging School Is Behind Us

As 'threatened' in my last column, I did execute a judging school in February. This was DARN well attended last Saturday the 16<sup>th</sup> at Corvette City. The subject was using the Standard Deduction Tables of the NCRS Judging Reference Manual. Sample parts (or pictures of parts) were laid out in five categories. The class was broken into 2-man teams specifically pairing more experienced judges with less experienced judges to level the playing field and share knowledge. Each team was given a sheet of questions to answer about the parts that were provided and supplied a working copy of the Standard Deduction Tables. Since there's often an interaction between the Flight Score Sheets for a given Corvette, the applicable Judging Guide covering that model year and the Standard Deduction Tables, Ralph Ridge graciously played librarian controlling access to the Chapter's judging support library.

The competing teams worked for just over two hours on the questions provided and roughly mid-way through the working session lunch arrived in the form of hot fresh pizza pies. Folks found they could grab a slice or two and continue to work on the questions without hardship. When time was up, we adjourned to chairs and I passed out answer sheets. An interactive lecture ran for roughly another hour where we discussed the 'why' factor(s) that stood behind the answers to the questions.

My hat goes off and I bow/salute Messrs Rick Reiff and John Marsico! Yep, they caught a legitimate error in one of the questions I posed (how to apply the deduction tables to an engine block and stamp pad). But, that only enhanced the school since the objective was to get up close and personal with how to correctly interpret and apply our club judging rules!

#### The Judging Retreat

As I write, RMC is well represented down south in Dallas, Texas at the National Judging Retreat. Specifically, I know Eckhard Pobuda, John Marsico, and John Hilborn made the trip and my recollection is they were NOT alone.

The retreat is a special school that's conducted every now and then by the National Judging Chairman. It's a multiday affair that pairs younger judges with more experience Master level judges. The school combines classroom lecture(s) with role playing in an atmosphere backed with bona fide examples of historically significant sample Corvettes. wThis is the FASTEST way for a novice judge to earn judging points and garner a significant learning experience. The retreat is VERY helpful for those who reside outside of North America as it packs a LOT of information into a few days of intensive schooling.



#### Looking Ahead

As the weather warms, we'll be looking ahead to the driving and judging season. Our judging 'action' here goes on 'hold' until the next judging school in August. That's followed by our traditional annual judging meet in September.

In between, there are seven of us who are planning on attending the 2013 British/Dutch judging meet at the 24 Heurs du Mans endurance race in LeMans France this June. Visiting Europe and driving in a Corvette caravan across the continent is a REAL HOOT! I'll be thinking of you...

Also, once again Ralph Ridge is running an RMC leg of the National Road Tour from Denver to the NCRS National Convention in Hampton, Virginia. I've heard our friends and fellow RMC members Wendy and Murray Forman from Australia will be back to enjoy summer weather with us in July. So, the big warm world of NCRS and Corvette is just waiting to break out on us!
