About Registration

This meet was advertised in Driveline starting in January. It was also discussed at our 1^{st} quarter chapter meetings where registration forms were provided. Last, registration forms have been on the RMC website since January as well.

We structured the meet to be free to all except those paying judging fees, PROVIDED you preregistered. That didn't work...

As of the March 1st pre-registration cut-off, less than half of those attending and/or bringing cars for judging had registered. We moved the registration deadline by 10 days to expand participation. In the end, we totally waived our late registration fee and registered folks at the meet...

We HAVE to do a better job here! To put on an event we need visibility of those who'll be there in order to form the judging teams, crank out the paperwork, and get the lunch count right. It's NOT a matter of drumming revenue for the chapter, it's a matter of complying with NCRS governing rules (ALL who attend a meet MUST register) and being able to plan for a smooth sailing event.

I know months out you may not know your work schedule and/or travel plans. But, waiting until the 11th hour isn't the solution... Burn that postage stamp and do us the favor of putting your name on the list. The worst that can happen is you have a conflict and can't attend!

Looking Ahead

In May, we have a Regional Meet at Lake Tahoe scheduled for 5/14-5/16 and the word is RMC will make an active showing of both cars and people. For the swap meet folks, Coy's annual event at Bandimere Speedway is docketed for Saturday, May 2^{nd} .

The NCRS National Convention is set for San Jose, California on July 12-16th. Ralph Ridge is leading an RMC leg of the National Road Tour that departs July 5th and I expect it will be well attended. March 2009 NCRS BOD Meeting

The BOD meeting was held in St. Louis for the second year. It most likely will continue there for reasons of travel for most of the BOD members and employees rather than the convention site as in the past.

Highlights of the meeting were; President Vito Cimilluca was elected to office for another year. Vito reappointed Mark Lincoln as Vice President and National Activities Chairman. Other one year appointments made by President Cimilluca include; Cece Nelson as secretary, Roy Sinor as National Judging Chairman, Gary Mortimer as Merchandising and Membership Manager, John Pirkle as National Corvette Museum Representative and Carlton Colclough as Public Relations Coordinator. Jeff Cook affirmed Finance Manager.

Mark Lincoln was appointed the Business Manager – Mark will chair the newly formed Business Management Committee. Vito Cimilluca and Jeff Cook will also be part of the Business Management Committee. This committee will establish policy regarding employee's performance and Mark will be the manager of all employees. Previously this was somewhat vague and handled by the Finance Manager.

Reconfirmed by the Board was, Vinnie Peters as *The Restorer* Editor, and Eric Mortimer as the *Driveline* editor.

Reappointments to the Publications Committee were Dick Whittington, Chairman, Vito Cimilluca and Jeff Cook. Ed Vignone was appointed to replace Mark Lincoln.

Darold Shirwo presented a proposal for the 2012 National Convention. The Board voted for the 2012 National Convention to be held in San Diego, California. The Board appointed Darold Shirwo as the Convention Chairman.

The Board voted to support six Regionals for 2011. The Regionals will be held in the following sites: Kissimmee, FI - January 26-29; Joplin, MO – April 28-30; Wildwood, NJ – May 19-21; London, Ontario Canada – June 9-11; Sacramento, CA – October 6-8; Waco, TX – October 20-22.

The Board accepted the proposal submitted to form an NCRS Wichita Kansas Chapter. They are to establish a name for the Chapter other than Kansas Chapter since there is a Kansas City Chapter today. This would eliminate confusion of the chapters names in Kansas.

John Pirkle reported that the National Corvette Museum expansion is on schedule to be complete by the end of April, 2009 for the Labor Day/15th Anniversary Celebration. NCRS member John Hinckley will be inducted into the NCM Hall of Fame during the Labor Day celebration. John Pirkle also reported that the NCRS Library and Archives is complete and open for business. National Corvette Museum now has a new library and archives featuring NCRS and singular Corvette collections. Betty Harrison, the Archives Manager says they now have over 900,000 build records, plus service manuals, a collection of Larry Shinoda drawings, and 1954 full scale drawing and clay model.

Roy Sinor announced that Brian Pearce, current 1978 to 1982 National Team Leader, will take on the added responsibility as the 1973 to 1977

National Team Leader. Nick Culcowski is the new 1967. Roy also announced a new award, NCRS Challenge Car Award to recognize unique 1988. 1989 and 1990 Corvette race cars announced **Ouality Assurance & Training Advisors remain the** same. Garv Chestnut is the 1956-57 manual coordinator. Dave Heitzman is now the Solid Axle manual coordinator. Mike Murray is now the 1965-1967 Technical Information Manual & Judging Guide coordinator. Duane Ravenberg will remain as the 1963-64 Technical Manual & Judging Guide Coordinator. 1978-1982 Manual Coordinator is Ken Sleeper. 1984 and up manual coordinator is Allen Tremain. A point of order is to make any suggestions to the Team Leader of the respective class and copy the coordinator so both are aware of your suggestion.

The Award confirmation document program has been very successful in terms of money and memberships.

The NCRS Information Technology team reported that the *Driveline* on-line has been implemented. The Board approved the implementation of on-line Regional Director voting program which should be ready for Regions I, II and III elections.

The proposal to waive the registration fee for the National Team Leaders at NCRS Regionals and the annual NCRS National Convention was approved by the Board. This was approved in an effort to reduce the total annual expense each Team Leader spends for travel, food and lodging to attend the National events.

Chapter Reports -

- Carlton Colclough reported that 20 Chapters participated in the 2008 NCRS Charity Program
- Marilyn Heitzman reported that 21 Chapters achieved Chapter Top Flight status in 2008 and will receive banners at the 2009 NCRS National Convention.

Three amendments were made to NCRS by-laws

Addition to §6.1: The President may elect to serve on any committee as an additional member of such committee as described in these by-laws.

Revision to §6.5: [The Business Manager shall be responsible for the general business operations of the club including supervision of] all employees and managers. The Business Manager will chair the Business Management Committee which will include the President and Financial Officer.

Addition of §22.5: Team leaders will not be required to pay registration fees for Regional events and National Convention effective 2010.

NCRS Foundation: The Foundation has received numerous contributions which have made it possible to go forward with the Scholarship Program. Mark Lincoln and Joan Burnett have put together the selection and eligibility guidelines and will be working on the selection process.

The next Board of Directors meeting will be July 17, 2009
