That's it for now. Have a great spring!



### Dear RMC members:

I have the following information regarding our road trip to Canon city on May 21. If you are planning to go please contact me and let me know if you plan to make it a day trip or if you are planning to overnight in Canon City, as Terri and I plan to do. Regardless of your choice, we can all caravan down together.

Meeting place is at Monument Exit 161, at the "Coffee on the Go" red trailer. Look for it on your right as you pass under the overpass approaching Monument. Take exit 161, follow the ramp to the stop light. Go straight through the light at the end of the ramp (hopefully when it is green). Turn into the first parking lot on your right. You will see the red Coffee To Go trailer sitting in the middle of the parking lot. We should meet at around 8 AM and be underway by 8:30. This will put us at the event by 9:45 AM. Our route will take us to Colorado Springs where we will exit at motor city to S. Nevada which becomes HWY 115. Travel south on 115 to Penrose and then west to Canon City on Hwy 50. Driving time 1 hr.15 minutes per Mapquest. Of course, for those of you who plan to come down but not enter the show, you have the option of a more leisurely departure.


For those planning to register for the 29th Annual Antique/Special Interest Car show, also known as The Royal Gorge Chapter of VMCCA on the grounds of the Holy Cross Abbey, you need to pre-register by contacting Kathy Kunselman at 719 275-3561 or mailing a check and the pre-registration form to her. See attached form above. Cut off for all registration will be at 400 cars so says the flier. Pre-registration is due by May 9. This allows club cars to be parked together. Pre-registration costs \$15 for show cars, \$20 for swap booth. Registration day of event costs \$25. Besides the Show Cars which will be judged, this meet includes Swap Meet, Flea Market, Craft Space and Car Corral for Sale Cars. Those who don't want to enter their car in the show, entry fee for spectators is \$3.

There is wine tasting at the Abbey all day until 6 PM. Yikes the ladies are in trouble! It is also possible for us to arrange for a special wine tasting table for our group perhaps towards the end of the Car Show. The winery is open until 6 PM. They are not offering their VIP tasting which includes bread and cheese due to the size of the event.

If the car meet isn't your thing, the Royal Gorge Train leaves around noon that day from the station in downtown Canon City. Your ticket can include a lovely ride,and gourmet lunch on a vintage vista dome car. Or you might be able to pay extra and ride with the engineer. We are not certain they still allow this, as a few years ago one of our members opted to do this and all along the way kept yelling "Deer, Deer"! Reportedly, the engineer was quite traumatized. ALL ABOARD!





Still doesn't speak to you....how about a visit to the swinging bridge atop the Gorge itself, a bungee jump, a cable car straight down, or a helicopter ride? Bring your sea legs and your nitro pills!

I have talked with several motels and have decided that the Quality Inn and Suites is the most convenient location, as it is next door to the Abbey. Besides John Wayne and Goldie Hawn slept here. They have negotiated their rates for our club at \$80 for a double queen room. Expect you could also get a king for same price. They are holding a block of 10 rooms. There are other options but less convenient. The Hampton Inn seems to be the top of the line, but their rack rate is \$135. If you call the Quality Inn motel, speak with Sara or be sure to tell the clerk you are with the Rocky Mt Chapter of NCRS Corvette club. 719 275-8676.

Our choice for dinner that night is Merlino's Belvedere Italian/Steak House on back road to Florence, just outside of Canon City. They have been in business for 4 generations in the same location. I am sure they can accommodate a large table if we plan ahead. Terri and I have been going there for years and are fascinated by their history and their home cooked meals. Again there are other options. Folks speak highly of the French restaurant and also of the Queen Ann Tea Room.


For those of you traveling home late in the afternoon, we recommend a stop at Juniper Valley Inn about 20 miles north of Penrose near Turkey Creek area on Hwy 115 on your right....Absolutely charming place. There is also an alternate route home which follows Highway 9, turnoff just West of Canon City, and goes to Hartsel and Fairplay and then home on 285. Another scenic route out of Guffey goes to Florissant/Cripple Creek area and down Hwy 24 Ute Pass to Colo Springs or turn off at Woodland Park on Hwy 67 and head up to 285 through the burn area.

# TECH SESSION WITH JIM HILTON AND JIM LENNARTZ





It's winter time and the 62 Corvette is in the garage waiting for spring to return. Normal winter maintenance is oil change, valve adjustment, tire rotation. This year I decided to insulate the interior floor boards with with a thermal barrier to minimize the heat in the interior compartment. I sent off for jute backed aluminum covered roll of insulation a can of adhesive spray and a roll of aluminum tape (this is the same stuff as is used to connect your house heat duct works ). What you need in tools is a phillips screwdriver, magic marker, scissors, razor blade holder, and 1/2 wrench (Kathy my wife was helpful at times also ). Some suppliers of the insulation have it pre cut. The one I picked you had to cut from a roll. The following instructions are for a C1 install. Unbolt the seats and remove from car. Unscrew the side kick panels, package tray, and package tray support fiberglass. Take the carpet up. Now is a good time to use carpet cleaner on the carpet to get it clean in all










the hard to get at places when it's in the car. Use the carpet as your pattern for cutting the insulation. The magic marker on the foil side marks your pattern, and the foil will be the top side when it is installed. When all is cut start at the firewall and work towards the back of the car placing the insulation down. I only used the spray adhesive on the transmission and driveline tunnel to hold the insulation in place. When you are satisfied with the fit use the aluminum tape for all joints to keep in place and keep heat out. The one place I had to remove more insulation was under the gas pedal. The insulation and carpet was to thick for the gas pedal to stay on the pegs, so I had to remove a little at a time to get the correct fit. Put the carpet back on top of the insulation (I did not spray any adhesive on the carpet install Use your judging guide to ). put the upholstery screws in the correct place of your carpet to firewall. Clean and wax your kick panels, package tray support and package tray and reinstall. Seats go back in. Any help this insulation can provide will be appreciated in blocking interior heat while cruising in the summer time. Hope this helps and keep driving those Corvettes.
